I understand that the dangers of athletic participation may result in not only serious bodily injury, but serious impairment of my future ability to earn a living, to engage in business, social and recreational activities and general enjoyment of life. I also understand that participation in outdoor sports activities have inherent risk and dangers from heat stroke, heat exhaustion and foreign objects hidden beneath the playing surface and spectator area, that could cause death, serious injury or bodily harm.
